### Invitation for Bids

1. **Mapya Dudhkoshi Rural Municipality, Khastap, Solukhumbu** invites electronic bids from eligible bidders for the construction of Emergency Dismantling, Construction and Reinstallation of Miteri Bridge at Orlangghat, Solukhumbu under the Contract for MDRMNCBWORK20818202 under National Competitive Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 7,65,00,000 (Seven Crore Sixty-Five Lakhs Rupees).  
Minimum Work experience of similar size and nature:
  - Construction of Motorable Truss/ Modular Bridge of Single Span More than 39m in Length.
  - Providing and Laying of Cement Concrete of Grade M25 of Quantity 210m<sup>3</sup>.
  - Providing, Laying, Fitting and Placing of Reinforcement bar of quantity 54,000 kgs.
  - Rotary Core Drilling for Rock Anchor of 60m length in Bridge Foundation.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 noon 2081-12-10 (23 March, 2025)** at the office of **Mapya Dudhkoshi Rural Municipality, Khastap, Solukhumbu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **12,80,000** which shall be valid for 30 days beyond the validity period of the bid.
